ACKNOWLEDGEMENT, WAIVER AND RELEASE

(Please read carefully)

- 1) In partial consideration for being admitted and allowed participation in all or any activities being conducted by Hatfield Farm Incorporated on lands occupied by it at Hammonds Plains, Halifax Regional Municipality, Province of Nova Scotia, the undersigned, for myself, my heirs, executors, administrators and assigns, fully release Hatfield Farm Incorporated, its servants, agents, or employees and its landlords from any claims, demands, damages, actions or causes of actions arising out of or in consequence of any loss, injury, or damage to my person or property incurred while attending at or participation in any or all of the activities of Hatfield Farm Incorporated, notwithstanding any such loss, injury or damages may have arisen solely or partly by reason of negligence of Hatfield Farm Incorporated, its servants, agents or employees, or its landlords.
- 2) I further state that I am in proper physical condition to participate in all or any activities of Hatfield Farm Incorporated and I acknowledge that I am aware that such participation could result in physical injury and/or property damage to me.
- 3) Without limiting the generality of the foregoing, the undersigned assumes all the risks associated with the above activities. I recognize that horses are living animals and each horse has a different nature and temperament and that other animals also on the Hatfield Farm Incorporated premises are also unpredictable. I acknowledge and accept that there is risk in riding horses or being transported in wagons or sleighs by horses and horses or other animals may act unpredictably, particularly but not limited to being frightened, provoked, hurt or by being in any way mistreated, or for no particular reason. I recognize that there is risk in participation in, or being a spectator at Hatfield Farm Incorporated Games, or other forms of recreation, being present in areas of fires, or being present at any party where people seek to enjoy themselves, including during hours of darkness or in bad weather, and I accept these risks. I also recognize and accept the risks of slippery or uneven or other wisely faulty or defective land surfaces over which I may ride, or be transported, or may walk, or play, or in the buildings in which I may enter. Knowing the inherent risks, I accept that Hatfield Farm Incorporated, its servants, agents, employees and its landlords do not accept any liability for any damage, injury to my person or any other person or property whatsoever, and I agree to indemnify Hatfield Farm Incorporated, its servants, agents, or employees and its landlords against any claim involving me or my minor children (if the latter is applicable). I accept that Hatfield Farm Incorporated, its servants, agents, or employees and its landlords make no representation in of any warranty of any kind expressed or as implied as to the nature, habits, and disposition of any horse(s) or animal(s) or the condition of any materials, equipment, or wagons, or sleighs, or the safety of any activity, or the condition of the Hatfield Farm Incorporated premises including the maintenance or lighting of these premises, or any of its buildings(s) which I might enter. I further acknowledge and accept that liquor is consumed on the Hatfield Farm Incorporated premises and I accept all risks of any injury or damage which may occur to me or my property or person caused in part or in whole from liquor consumption whether it arises from my own consumption of liquor or that of others.
- 4) I the customer will not permit the horse selected for my personal use and the use of my child to be exchanged with other riders or permit any person than the selected rider to ride the horse or permit the doubling of any person, including children, unless specifically authorized and unless accompanied by an instructor. The rider will be responsible for the correct adjustment of all harnesses, saddle and stirrups prior to and during the ride and for the embarking and disembarking on and from the horse and likewise from all games or equipment or fire pit or activity of any kind on the Hatfield Farm Incorporated premises.
- 5) I the customer if riding a wagon or sleigh, will be responsible for my own positioning and that of my child on the wagon or sleigh and for anything that happens to them while getting on the wagon or sleigh or riding in the wagon or sleigh or getting off the wagon or sleigh.
- 6) All accidents or injury to persons or damage to property loss of equipment must be reported to the Hatfield Farm Incorporated Office Manager in writing before leaving Hatfield Farm Incorporated premises and my failure to do so shall automatically completely release from any claim by me, Hatfield Farm Incorporated its servants, agents, or employees and its landlords.
- 7) All instructions by the Hatfield Farm Incorporated staff shall be observed by me and my failure to do so shall release any claim by me.
- 8) All directional and information signs on the Hatfield Farm Incorporated premises will be read and obeyed by me and my failure to do so shall release any claim by me.
